President Richard Collins opened the meeting at 10.30am.

Minutes of 2005 AGM

The Secretary Don Wiseman read the minutes of the last AGM on 22nd March 2005 and moved that they be accepted as a true record of the meeting This motion was seconded by Gordon Maxwell, and accepted.

Financial Report for the year ending February 2006

Treasurer Nev Owen gave a very full report of the club's financial position over the last year. Every member was given a copy of full balance sheets of General and Social Accounts.

The Treasurer said the accounts had been audited by Gordon Maxwell in accordance with current regulations and moved that they be accepted. This was seconded by Murray Coutts and agreed by the meeting.

Fees for next year

President Richard moved that the joining fee remain at \$20.00 and the Annual Subscription remain at \$30.00 for the ensuing year. This motion was seconded by David Dunbar. In speaking to his motion, Richard reminded the meeting that the proposed web site had not become active during the year due to Geoff Veel's death, and therefore no costs had been incurred from this initiative. Even so, the Club had still only just broken even for the year due to the lower than anticipated number of new members. Richard said that the Committee had examined the likely income and expenditure for the next year, and had calculated that, if the fees remain unchanged and there is no web site, income and expenditure will be nearly equal. If the web site gets up and running during the year, a slight deficit is likely. It was on this basis that the Committee had decided to recommend that the fees remain unchanged. After some discussion, the motion was agreed unanimously.

President's Report

President Richard first stated that, during his year in office, he had intended that the Club concentrate on those things for which Probus had been formed – fellowship, fun and mutual support – and he believed that we had done this well.
